

## Doug Avery Book Prize Draw Terms and Conditions

1. The promoter is: The Royal Highland & Agricultural Society of Scotland (RHASS) (Scottish charity number SC004561) of Ingliston House, Royal Highland Centre, Ingliston, Edinburgh, EH28 8NB.
2. The competition is open to members of RHASS aged 16 or over except employees of RHASS and their close relatives and anyone otherwise connected with the organisation or judging of the competition.
3. There is no entry fee and no purchase necessary to enter this competition.
4. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
5. Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.
7. Closing date for entry will be 10<sup>th</sup> January 2019. After this date no further entries to the competition will be permitted.
8. No responsibility can be accepted for entries not received for whatever reason.
