Minute of a meeting of the **239**th **ANNUAL GENERAL MEETING** held in the Pavilion at Ingliston, with Members joining in person and via Zoom, at 4.00pm on Thursday 27 April 2023

Preamble

- P.1. The Chairman, Jim Warnock (JW), welcomed all to the meeting. He reflected on a year of positivity, with the return of the RHS, but also a year of significant challenges, with significant uncertainty around Covid still remaining in the first half of the year under review.
- P.2. Ian Duncan Millar, RHASS' president took the Chair. The Secretary confirmed that the Meeting was quorate and the President called the meeting to order.

AGM01/04/23 Minutes of the 238th Annual General Meeting (AGM) held on 28 April 2022 and the General Meeting held on 26 October 2022.

1.1. **The minutes for both meetings previously distributed were approved** on the motion of Fiona Roebuck, seconded by Neil Thomson.

AGM02/04/23 Report and Audited Accounts for the year ended 30th November 2022

- 2.1. John Sinclair, Honorary Treasurer, (HT) spoke to the Annual Report which had been approved by Board.
- 2.2. He said that the Board had budgeted for a deficit, in the knowledge that the recovery from the impact of the pandemic would not be accomplished in one year. The cost of living crisis and inflation had impacted across the board. The outturn of a £1.2m loss was an improvement of £0.5m on the budget for the year. He recalled that it was uncertain if the Society would be able to hold the RHS when the financial year had started.
- 2.3. £1m of the loss reported related to depreciation for sound capital investment decisions made prior to the pandemic, including building the Pavilion, a fantastic event space.
- 2.4. Colin Crosby, independent Chair of the Audit Committee, reported on the process to approve the accounts, confirming the external Auditors had given an unqualified report.
- 2.5. He said that internal auditors had been appointed during the year examine and report on a number of operational areas. This would be an initial three-year programme of work; the purpose of which was to give assurance to the Board and members that the governance of the Society was in line with current and evolving best practice. The first report focussed on organisational structure and efficiency and agreed recommendations would be implemented. The next internal audit would look at risk and risk management.
- 2.6. Alan Laidlaw, Chief Executive, spoke on the Society's future plans. He said that, to ensure the financial stability of the organisation, RHASS would continue to seek to increase income and contain

costs, exploring new income streams within the charity and group, including a greater focus on fundraising on the basis that by raising more funds, the Society could do more for Scottish Agriculture and rural Scotland. RHASS had taken conscious decisions to invest in areas of importance to its charitable remit. The Society had to be agile and able to adapt to changing events. He noted that the economic environment was likely to remain challenging for some time.

Questions

- 2.7. Janice Milne (JM) asked how the cost-of-living impact had impacted the staff and whether staff on the lower end of the salary spectrum had received a proportionately higher salary increase than those on higher salaries. This was in the context of note 15, staff costs, which showed one of the higher salaries moving up two bands.
- 2.8. John Sinclair (Honorary Treasurer (HT)) said that the increase from the prior year reflected the voluntary salary cuts taken by the senior management team through Covid. These were progressive with those on higher salary bands taking the biggest cut. The increase highlighted was due to reversing those cuts along with the award of a cost of living increase this year as reported in the accounts. He said that the Remuneration Committee took professional advice and benchmarked salaries.
- 2.9. JM said she recognised staff were the Society's greatest asset and her question was focused on whether those on lower salaries received a proportionately higher increase. HT said that all roles were benchmarked to ensure they were appropriately remunerated to ensure the Society was well managed and governed without paying more than required, as a charity. JM suggested all staff salary ranges could be published in the annual report.
- 2.10. Jennifer Welsh asked why RHASS had chosen to defer life membership over 20 years. This was a change made on the recommendation of the auditors to reflect the actuality of life membership more accurately.
- 2.11. The Report and Audited Accounts and Special Grants for the year to 30 November 2022 were adopted by the meeting on the motion of HT, seconded by Dennis Bridgeford.

- 5.1. **The re-appointment** of Azets Audit Services, Exchange Place, 3 Semple Street, Edinburgh, EH3 8BL as the Society's auditors for the financial year to end 30 November 2021 **was approved** by the Meeting on the motion of Colin Crosby, seconded by Kay Adam.
- 5.2. **The Meeting noted** that the Audit Committee was delegated by the Board to agree the Auditor's fee.

AGM06/04/23 Session Dates

6.1. The first date of the 2023-2024 session of 14.30 hours on Wednesday 19 July 2023 was noted by the meeting and the last date of the 2023-2024 session and first date of the 2024-2025 session was approved as Wednesday 17 July 2024 on the motion of James Logan, seconded by Anne Logan.

AGM07/04/23 Member questions

7.1. The President invited questions from the floor, there having been one question submitted prior to the meeting.

- 7.2. James Muir asked how many members could not be contacted by email and how communications with those members were delivered. The Secretary said that RHASS had approximately 16,400 members, and about 2,000 of those did not have an email address linked with their account. RHASS wrote to those for whom it did not have an email address about membership renewals and tickets for the RHS. The Society magazine was also sent to all member households.
- 7.3. The Secretary said that moving to email communications for the majority of our members helped the Society to reduce costs and the environmental impact of printing and posting and also helped RHASS to communicate more regularly with its members on matters of interest to them.
- 7.4. Robert Johnston asked if there would be any impact on the RHS of the City of Edinburgh's move towards plant-based food. Alan Laidlaw said that RHASS would continue to represent the whole of agriculture and engaged with City of Edinburgh and other key stakeholders to ensure that the whole of Scottish agriculture was represented. The RHS would continue to celebrate all food and rural life.
- 7.5. Guy Hodgson asked about the ticketing agent for the RHS, Ticketmaster. CE said Ticketmaster had still been in place at the launch of the RHS 2023 tickets. He said SEE tender had now been appointed in place of Ticketmaster, with positive feedback. A farming flexi ticket had been introduced following feedback.
- 7.6. Willie Allan asked if RHASS considered it ethical that the Holiday Inn Express (HIX), the nearest hotel to the RHS, charged significantly higher rates over the Show week. Elizabeth Bridge said when she tried to book a room at the HIX for the RHS she was told there were no rooms available and this was to accommodate the RHS. Alan Laidlaw said that whilst RHASS had a contractual arrangement to take rooms for the Show week, the Society had no influence over the hotel's pricing, it was run by a third party. It was noted that hotel prices in Edinburgh had risen substantially. Guy Hodgson suggested that RHASS could run its own hotel. Alan Laidlaw said that RHASS was a charity and not in the business of running a hotel. The Society was very mindful of the challenges of finding accommodation and did what it could to assist, including keeping caravan pitch prices as low as possible.
- 7.7. Jane Thomson asked why the Society could not get special hotel rates for Show exhibitors. CE said RHASS had relationships with local hotels but they were global chains and RHASS had no influence over their pricing model.
- 7.8. Jane Thomson asked if the £420,000 expenditure reported in the annual reports against music and special events included the Big Top concerts and asked if RHASS proposed to run them again. In response, CE said the income and expenditure from those concerts was reported through RHASS's trading company, Highland Centre Ltd. The category of music and special events included other Show matters, including RHS TV.
- 7.9. Jane Thomson further said there were difficulties with the online booking for the exhibitors' car park for the RHS. CE said this was not an issue that had been raised previously but it would be looked into. He suggested she speak to the Show team on any specific issues.
- 7.10. Reflecting on these questions, the President said it was important to remember that the work of the Society was not limited to the Royal Highland Show and its charitable remit continued throughout the year.
- 7.11. The President said that Kathryn Stephen had submitted a question in advance of the AGM. She had suggested that a newsletter be sent to members in different areas. Jim Warnock, RHASS Chairman, said that there had been a lot of work put into members communications and the Board would continue to work on that.
- 7.12. Jimmy Smith asked about RHASS support for local shows. CE said RHASS had launched a specific fund to support local shows, which had had a very strong response. The Society would look at continuing this programme into the next financial year.

Jim Warnock closed the meeting with a vote of thanks to the President. He thanked all for their attendance and wished the Society a successful, safe and prosperous year.
